Youth Development - Lifeline partners with law enforcement, schools, cities, and other community organizations to reduce truancy/juvenile delinquency and prevent youth from joining local gangs. Lifeline works with youth picked up for minor offenses and misdemeanors and their families, and provides counselling, mentoring, parent education and connects them with services that best meet their needs. Intensive gang prevention and intervention services are provided in the cities of Vista and Oceanside.

4b (Code: ) (Expenses \$ 2,722,303. including grants of \$ 81,978.) (Revenue \$ )

Behavioural Health - Students age 17 and under in seven north San Diego County school districts who meet medical necessity requirements according to title 9 of the California code of regulations are eligible to receive mental health outpatient services. Youth must be MediCal eligible or designated as AB 2726 on their individualized educational plan (IEP), indicating that their emotional needs exceed the scope of a school counsellor or psychologist. Program services are provided primarily on school campuses, in the client's home or at a Lifeline clinic, and include individual, group and family therapy; rehabilitation services; medication support; case management brokerage; and crisis intervention as needed. Youth and families are connected with medical, social, rehabilitative, or other community services and supports.

Child Abuse and Domestic Violence Prevention & Intervention - Lifeline provides comprehensive prevention and intervention services to families impacted by child abuse and family violence. Services include home-based parenting services using evidence based practices, parenting education and groups, and assessments of those impacted by abuse. Additionally clinicians provide group based therapeutic services to men and women referred by the courts for domestic violence risk and anger management issues.
